It is to certify that school premises of Devbhoomi Adarsh Vidyalay (DAV) Khasra No. 69/11 (Administrative Block, Academic Block) Village Kalyan , P.O. Kakkarhatti Tehsil Kasauli Distt. Solan (H.P.) was inspected by me along with the M.D. of the school on 21/08/2024 with regard to the physical condition of the building in the premises.

During my visit I found that the structure of the building is made of R.C.C. Columns, beams and flat roof slabs at the top. The walls are made up of brick works in cement mortar duly plastered. I have not seen any visible defect in the building on inspecting it physically from outside & inside above plinth level. I have been informed to your school M.D. that the construction of footing and other foundation, not visible now has been done by the School Management as per the drawings shown to me and other construction of the footing, columns , beams, roof, slabs, stairs and flooring have been executed as per Indian codes of the structural design by taking all the loads including earthquakes. The following was the findings:


The civil construction works executed by the School Management were in good quality.

The building seems to be good looking after and structure seems to be in good condition under normal condition.

The structure are seemed to be safe and stable as viewed physically.
