1. The School shall abide by the provision of Right of Children to free and Compulsory Education rule.2011 (Annexure-II).
2. The Society / School shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure.
3. The School shall not deny admission to any child
 - (i) For lack of age proof.
 - (ii) If such admission is sought subsequent to the extended period of 90 day for admission.
 - (iii) On the ground of religion, Caste or race, place of birth or any of them
4. The School shall ensure that,
 - (i) No child admitted shall be held back in any class or expelled from school till the Completion of Elementary Education in that school.
 - (ii) No child shall be subjected to physical punishment or mental harassment.
 - (iii) No requirement to pass any Board examination till the completion of Elementary Education.
 - (iv) Every child completing Elementary Education is awarded a certificate as laid down under rule 19 of the Right of Children to free and Compulsory Education, Himachal Pradesh Rule,2011.
 - (v) Student with disabilities/ special needs are given admission as per provision of the Act,
 - (vi) The teacher is recruited with minimum qualifications as laid down under section 23(1) of the act.
 - (vii) The current teachers who, at the commencement of this Act did not possess minimum qualification shall acquire such minimum qualification by, 2015 2025
 - (viii) The teacher performs his/ her duties specified under section 24(10) of the act, and
 - (ix) The Teacher shall not engage himself or herself for private teaching activities.
5. The School shall follow the syllabus on the basis of curriculum laid down by academic authority under-sub section (1) of section 29.
6. The school shall enroll students proportionate to the facilities available in the school specified the section 19 of the Act.
7. The school shall maintain the standard and norms as specified in section 19 of the act. The facilities reported at the time of last inspection are give under:

10. No unrecognized classes shall run within the Premises of the school or outside in the Name of school.
11. **The school building or other structures or the grounds shall not be used during the day or night for commercial or residential purpose, or for political or non- educational activity of any kind whatsoever. Except of the purpose of residence of any employee of the school**
12. The School shall be run by a society registered under the Societies Registration Act, 1860(21 of 1860) or a public trust constituted under any law for the time being in force.
13. The School shall not be run for profit to any Individual group or association of individuals or any other reasons. Education Officer every year.
14. The accounts of the school shall be audited and certificate by a Chartered Accountant and proper accounts statements shall be prepared as per rules. A copy each of the Statement of Accounts shall be sent to the Deputy Director/ Block Elementary Education Officer every year.
15. The recognition code Number -allotted to your **school 256/2023-28 this may please be noted and quoted for any correspondence with this office.**
16. The School shall furnish such reports and information as may be required by the Director of Education/ Dy. Director / Block Elementary Education Officer from time to time and comply with such instructions of the State Government/ local authority as may be issued to secure the continued fulfillment of the condition of recognition or the removal of deficiencies in working of the School.
17. Renewal of Registration of Society if any is ensured.
18. Renewal of recognition shall be ensured every year after depositing renewal fee of Rs 500/- before 15 days of the commencement of the academic session.
19. The State Govt. may specify additional conditions form time to time, for compliance.
20. **It may be ensured that teachers appointed in the school are TET qualified.**
